Dear Jake: [Did I spell it right?]

I want to thank you and your entire firm for a difficult task, WELL DONE!
My daughter Marceia without being told anything, got the correct impression, that I was in BIG trouble with YOUR UNCLE SAM, the Internal Revenue Service. They had sent me several threatening letters, that I had to sign for, so they could prove to a judge 'I was not paying taxes, thereby not paying his salary. [Ha Ha] She didn't know, nor do I, why I hadn't filed any tax returns to them or the state for the last four years, 2009,2010,2011 or 2012. They filed a notice with the courts they were about to file LIENS against my house, bank accounts, my car and anything else 'they could lien against'.

[You see 'The Good Lord rewarded you by referring a client to you' ME, for eating KOSHER FOOD.] When we met in your office, and I gave you all my paperwork and the IRS threatening letters and notices about filing liens against everything I own, you said you 'would do the best that you could but didn't offer me any 'REDUCTION AMOUNTS'.

Once the court is advised liens are being requested, it becomes public knowledge. I received more than 50 letters from attorneys/accountants to represent me before the IRS. The liens they were going to impose were to have me pay the tax they calculated I owed, plus Interest and Penalty charges for the four years totaling over \$150,000. The year of 2009 by itself was \$40,000.

All of these professionals who offered to represent me said they would do everything that needed to be done, file all the taxes for the four years. They would be able to negotiate with the IRS, reducing the taxes due, the interest and penalty charges to 25% of what the IRS was looking for, approximately \$37,500. The year of 2009 by itself was \$40,000. and you got the IRS to accept \$1,299.70. You wrapped up the entire problem, \$153,000 including your fee, for \$18,459.00, approximately \$20,000. less than all the professionals who introduced themselves by mail.
